Zoning Administrator's Report

Thiessen reported he is still looking at County subdivision ordinance and how it can be incorporated into the Town ordinance, and at the new County Shoreland Zoning Ordinance. Will have a report and recommendations at a later date. Thiessen further reported that it is becoming clearer, based on conversations with County zoning officials, what portions of our ordinance can and cannot be enforced. Permits issued to date are running ahead of last year.

Secretary's Report

Hoehn presented his hours for approval. Motion by Johns, second by Bauers, to approve. Motion carried, with Hoehn abstaining.

Comprehensive Plan Update

Ken Jaworski of Martenson & Eisele presented the draft of Chapter 8, Land Use. The two biggest changes from the existing plan, other than certain additions and deletions of text and updating of charts and tables, are: 1. A consolidation of the three business classifications (General Business, Community Business, and Recreational) into one classification called "Commercial." This will result in giving the plan more flexibility. 2. Removal of the zoning maps and tables associated with zoning calculations to help ensure there is no confusion over what is "zoning" and what is "planning."

Draft text and updated tables and charts were reviewed, with several areas identified that require verification. Discussion on including a section on incompatible uses under airport runway approach/departure flightpaths.

Discussion on the last version of the revised SWOT.

Chapters 7 and 9 are to be reviewed at the June meeting with Bruce Mommoaerts.
